

The Emerging World Fund (Institutional)

Summary

During January, the share price of The Emerging World Fund (EWF) fell 2.17%, net of fees, whilst its benchmark index, the dollar-adjusted S&P Emerging Frontier Super Composite Net Total Return Broad Market Index (S&P Super BMI), fell 4.07%. Additionally, and for comparative purposes only, the MSCI Emerging Markets Net Total Return Index (MSCI EM Index) fell 4.64% over the period. The discount movements and NAV performances of the Fund's underlying holdings, as well as country allocation versus the benchmark index, were all favourable. Since its inception in September 1998, the Fund has outperformed its benchmark index on an annualised basis by 0.71 of a percentage point and outperformed the MSCI EM Index on an annualised basis by 1.3 percentage points, net of fees. Please note attribution in the table below is shown gross of fees, whilst performance reported in the narrative above and chart below is net of fees.

Investment Commentary

Economic Overview* (Macroeconomics)

Global equities started the year on weak footing amid growing tensions in the Middle East, with the MSCI ACWI Net TR Index returning just 0.6% in US dollar terms during January. The Iran-backed Houthi rebel attacks continued to disrupt maritime trade across the Red Sea and the Gulf of Aden, leading to rising shipping costs and risking the progress made on global disinflation. Threats to oil supply offset concerns over slowing demand growth, allowing the Brent crude oil price to gain 6.1%. Softness in commodity markets outside energy meant that the Bloomberg Commodity TR Index was practically flat at 0.4%. Accordingly, the energy sector (+4.6%) was the only emerging markets sector to post positive returns.

In rates, the US yield curve steepened as US Treasury 2-year yields declined by 4 bps and the 10-year edged up by 3 bps. This was despite the Fed pushing back against market expectations of a March rate cut at its January FOMC meeting, noting that it was not appropriate to reduce the policy rate "until it has gained greater confidence that inflation" was closer to target. The US dollar Index (DXY) rose by 1.9%, while the MSCI EM Currency Index fell by 0.9%. Emerging markets (EM) equities (as measured by the MSCI EM Net TR Index) fell 4.6% in US dollar terms during January, underperforming developed market (DM) equities (as measured by the MSCI World Net TR Index) by 5.8 percentage points. This was the largest EM monthly underperformance since 1998.

China continued to be the biggest drag on EM equities, as the MSCI China Index dropped by 10.6% in US dollar terms, making it the second weakest MSCI EM Index after Chile (-11.1%). Factors behind China's weak performance included disappointment over support measures and concerns over US-China relations in the wake of Taiwanese presidential elections. The MSCI Korea Index was another soft spot, falling by 10% in US dollar terms following weak earnings guidance from tech and EV battery companies. EM Asia underperformed the broader EM Index by 0.6 of a percentage point. In contrast, the best performing markets were concentrated in the EMEA region, with Egypt, Turkey and Kuwait rising 19.8%, 10.3% and 7.0%, respectively. EMEA outperformed EM by 3.7 percentage points. Turkey's stock market was supported by the ongoing policy pivot. The central bank at its January meeting signalled that it had reached the end of its tightening cycle after raising the policy rate to 45%.


Portfolio Commentary* (Investment Management)

In January, global generalist exposure was reduced as we sold shares of Hansa Investment Company as the discount narrowed to 43% following strong gains in its largest underlying holding, Ocean Wilsons. Emerging markets generalist exposure was increased as we purchased shares of abrdn Emerging Markets Equity Income Fund Inc, JPMorgan Global Emerging Markets Income Trust, Mobius Investment Trust and Templeton Emerging Markets Investment Trust at discounts ranging from 9% to 15%. Frontier and exposure to smaller EMs was increased as we purchased BlackRock Frontiers Investment Trust at a 9.5% discount.

Exposure to emerging Asia was increased as shares of **abrdn Asian Income Fund** were purchased at an average discount of 13%. Exposure to China was increased as shares of **Fidelity China Special Situations** were purchased at a 10% discount. Exposure to South Korea was increased as shares of **Korea Fund Inc** and **LG Corp** were purchased at average discounts of 17% and 55%, respectively. Exposure to India was decreased as shares of **abrdn New India Investment Trust** and **JPMorgan Indian Investment Trust** were sold at discounts ranging from 16% to 17%. Exposure to Vietnam was increased as shares of **Vietnam Enterprise Investments Limited** were purchased at a discount of 18%.

South African exposure was decreased as we sold shares of **Remgro** at a discount of 40%.


Index Performances During January 2024 (US\$)

*Size Weighted Portfolio Discount represents the see-through discount of the underlying closed-end funds. It is calculated by multiplying the percentage position sizes of the underlying closed-end funds by their respective discounts. These calculations are then added together to determine the size weighted portfolio discount for the portfolio. The size weighted portfolio discount is a measure of value within the portfolio, with a higher value representing wider discounts, and accordingly more value within the portfolio.

**Some of the closed-end funds have either fixed maturities or continuation votes that allow shareholders to vote on a restructuring of the underlying closed-end fund. The size weighted portfolio life is calculated by taking the percentage position sizes of the relevant holdings on the portfolio and multiplying them by their respective time periods remaining to the corporate event. These calculations are then added together to determine the minimum size weighted portfolio life for the portfolio. A lower size weighted portfolio life is beneficial for the portfolio as it may equate to potentially more corporate activity in the near term.

Country Allocation (+0.02%)

(Relative performance is in US dollar terms and references the country's S&P Super BMI component or an appropriate market index versus the S&P Super BMI composite index)

Country allocation was slightly positive, with outperformance resulting from the Fund's underweight position to China (which contributed 22 basis points to performance) as its index underperformed the composite index. An overweight position to Vietnam (+16 bps) also contributed outperformance as its index outperformed.

However, the Fund's exposure to Hong Kong (-18 bps) contributed underperformance as its index underperformed.

Portfolio Holding NAV (+0.76%)

(Performances are quoted in US dollar terms against their respective S&P Super BMI component, or for out-of-benchmark exposure, against a comparable country or regional index)

NAV performances were positive as the NAVs of **Taiwan Fund Inc** (+37 bps), **Samsung C&T** (+25 bps) and **Fidelity Emerging Markets** (+18 bps) outperformed their indices by 6.1, 6.3, and 4.3 percentage points, respectively. **Taiwan Fund Inc's** NAV outperformed due to good stock selection within the information technology and industrials sectors; top contributors were Asia Vital Components, TSMC and Fortune Electric. The NAV of **Samsung C&T** outperformed as Samsung Biologics gained after reporting strong fourth quarter results; additionally, the holding company is an expected beneficiary of a US bill targeting Chinese competitors. The NAV of **Fidelity Emerging Markets** outperformed due to stock selection within the information technology and consumer discretionary sectors, with notable contributions from the overweight positions in TSMC, MakeMyTrip and MercadoLibre. From a country perspective, the underweight positions to China and South Korea, as well as the overweight position to India, contributed favourably to performance.

Some underperformance stemmed from **JPMorgan Indian Investment Trust** (-24 bps) as its NAV underperformed its index by 4.4 percentage points due to its overweight position and stock selection within the financials sector. An underweight position to the energy sector, as well as an underweight position to and stock selection within the healthcare sector, were also key detractors.

Discount Movements (+1.20%)

(Performances are quoted in US dollar terms unless specified otherwise)

Discount movements were positive as the discounts of Samsung C&T (+27 bps), Ocean Wilsons Holdings (+22 bps), and Prosus (+15 bps) narrowed by 2.4, 7, and 5.4 percentage points, respectively. The discount of Samsung C&T narrowed as low price-to-book ratio stocks rallied in South Korea after authorities announced plans to tackle the "Korean Discount". The discount of Ocean Wilsons Holdings narrowed on speculation that a sale of Wilson Sons, a significant holding, could be announced. The discount of Prosus narrowed as it continued to repurchase shares and as investors became more positive on the outlook for China.

Conversely, **VinaCapital Vietnam Opportunity Fund** (-6 bps) contributed underperformance as its discount widened by 1.8 percentage points as investors reduced exposure to Vietnamese equities.
