
The Emerging World Fund (Institutional)

April 2025 Month-End Report

Summary

During April, the share price of The Emerging World Fund (EWF) rose 0.5%, net of fees, whilst its benchmark index, the dollar-adjusted S&P Emerging Frontier Super Composite Net Total Return Broad Market Index (S&P Super BMI), rose 1.46%. Additionally, and for comparative purposes only, the MSCI Emerging Markets Net Total Return Index (MSCI EM Index) rose 1.31% over the period. The discount movements and NAV performances of the Fund's underlying holdings, as well as country allocation versus the benchmark index, were all unfavourable. Since its inception in September 1998, the Fund has outperformed its benchmark index on an annualised basis by 0.6 of a percentage point and outperformed the MSCI EM Index on an annualised basis by 1.08 percentage points, net of fees. Please note attribution in the table below is shown gross of fees, whilst performance reported in the narrative above and chart below is net of fees.

Benchmark changes have not been applied retroactively and therefore historical benchmark performance is a blend of the BMI and IFC indices. Investment Commentary

Economic Overview* (Macroeconomics)

Global markets sold off sharply following the announcement of higher than expected US reciprocal tariff rates on “Liberation Day” (April 2). Markets recouped most of their losses by the end of the month after US President Donald Trump paused the reciprocal tariffs for 90 days. However, the US tariff rate on China was hiked further to 145%, albeit with exemptions made for certain goods, such as electronic products. China responded by increasing its tariff rate on imports from the US to 125%. Despite concerns over the inflationary impact of US tariffs, the 2-year and 10-year US Treasury yields dropped by 28 bps and 4 bps, respectively, due to rising concerns about a US recession, which were compounded by the release of weak Q1 GDP data. The market is pricing in four rate cuts by end-2025, one more than was expected at the start of April.

Emerging market (EM) equities (as measured by the MSCI EM Net TR Index) rose by 1.3% in US dollar terms in April, outperforming developed market (DM) equities (as measured by the MSCI World Net TR Index) by 0.4 percentage points. The narrative of fading US exceptionalism took hold in April, with the US dollar (DXY Index) falling by 4.6% in the month. The MSCI EM Currency Index rose by 1.7%.

The strongest EM index was the MSCI Mexico Index, which gained 13% in US dollar terms. Mexico, along with Canada, was not included in the US’ reciprocal tariff list and as such its existing 25% tariff rate was lower than those faced by some other EMs. Additionally, the exemption of USMCA-compliant goods from this tariff rate was extended. Other strong markets were Hungary (+9.9%), Thailand (+7.2%) and Colombia (+6.6%). Brazil (+5.1%) and Chile (+3.2%) also saw gains and Latin America outperformed the EM benchmark by 5.6 percentage points. In Asia, the MSCI India Index gained 4.8% in US dollar terms as optimism around a trade deal with the US grew.

In contrast, the MSCI Turkey Index fell by 6.8% in US dollar terms, making it the worst performing EM. The CBT hiked the policy rate

(one-week repo rate) by 350 bps at its April meeting, while consensus had expected a hold. Elsewhere, the MSCI China Index declined by 4.3% in US dollar terms against a backdrop of escalations in the trade war.

In commodities, the Bloomberg Commodity TR Index fell by 4.8% as the declines in energy (-16.2%) and industrial metals (-6.9%) more than offset the rises in precious metals (+3.1%) and agriculture (+1.2%). Projections for weaker global trade and an increase in OPEC+ output weighed on the price of Brent crude oil, which dropped by 15.5%.

Portfolio Commentary* (Investment Management)


In April, emerging markets generalist exposure was adjusted as we sold shares of **abrdn Emerging Markets ex-China Fund Inc** at a 13% discount, while shares of **Fidelity Emerging Markets** and **JPMorgan Global Emerging Markets Income Trust** were purchased at discounts of 11% and 16%, respectively.

In Asia, generalist exposure was adjusted as shares of **Pacific Horizon Investment Trust** were purchased at an average discount of 12%, while shares of **abrdn Asia Focus** were sold at discounts as narrow as 11%. Exposure to China was increased as we purchased shares of **Morgan Stanley China A-Share Fund Inc** and **JPMorgan China Growth & Income** at discounts averaging 19.5% and 11%, respectively. Exposure to Taiwan was reduced as shares of **Taiwan Fund Inc** were sold into strength at a 16% discount. Exposure to Vietnam was increased as we purchased shares of **VinaCapital Vietnam Opportunity Fund** at a 31% discount.

In Latin America, Mexican exposure was increased as we purchased shares of **Mexico Fund Inc** at an average discount of 20.5%.

Index Performances April 2025 (US\$)



The objective of The Emerging World Fund (EWF) is to invest for capital growth in a portfolio of closed-end funds whose investment policy is directed mainly towards emerging markets. This approach allows great flexibility in asset allocation, a wider diversification of investments, participation in the performances of high quality fund managers and potentially enhanced performance when the discounts to net asset value at which closed-end funds tend to trade narrows. EWF is a sub-fund of The World Markets Umbrella Fund plc. ♦

*Size Weighted Portfolio Discount represents the see-through discount of the underlying closed-end funds. It is calculated by multiplying the percentage position sizes of the underlying closed-end funds by their respective discounts. These calculations are then added together to determine the size weighted portfolio discount for the portfolio. The size weighted portfolio discount is a measure of value within the portfolio, with a higher value representing wider discounts, and accordingly more value within the portfolio.

**Some of the closed-end funds have either fixed maturities or continuation votes that allow shareholders to vote on a restructuring of the underlying closed-end fund. The size weighted portfolio life is calculated by taking the percentage position sizes of the relevant holdings on the portfolio and multiplying them by their respective time periods remaining to the corporate event. These calculations are then added together to determine the minimum size weighted portfolio life for the portfolio. A lower size weighted portfolio life is beneficial for the portfolio as it may equate to potentially more corporate activity in the near term.

Country Allocation (-0.09%)

(Relative performance is in US dollar terms and references the country's S&P Super BMI component or an appropriate market index versus the S&P Super BMI composite index)

Country allocation was slightly negative, with underperformance stemming from an overweight position to Vietnam (which detracted 31 basis points from performance) as its index underperformed the composite index. An underweight position to Argentina (-11 bps) also detracted from performance as its index outperformed.

Conversely, some outperformance resulted from an underweight position to China (+23 bps) as its index underperformed.

Portfolio Holding NAV (-0.49%)

(Performances are quoted in US dollar terms against their respective S&P Super BMI component, or for out-of-benchmark exposure, against a comparable country or regional index)

NAV performances were negative as the NAVs of **Fidelity China Special Situations** (-11 bps) and **Ocean Wilsons Holdings** (-9 bps) underperformed their indices by 1.9 and 5.4 percentage points, respectively. **Fidelity China Special Situations'** NAV underperformed due to negative stock selection, primarily within the industrials and financials sectors, as well as the use of gearing in a falling market. The NAV of **Ocean Wilsons Holdings** lagged the gains in Brazilian equities as the holding company awaits completion of the sale of its entire interest in Brazilian port and maritime logistics operator Wilson Sons, which is expected to occur in the second or third quarter of 2025.

Some outperformance stemmed from **abrdn Asia Focus** (+14 bps) as its NAV outperformed its index by 3.5 percentage points due to the outperformance of Asian small-cap stocks relative to large-cap stocks. Stock selection was also positive, notably HD Korea Shipbuilding & Offshore Engineering, Kfin Technologies and HD Hyundai Marine Solution.

Discount Movements (-0.30%)

(Performances are quoted in US dollar terms unless specified otherwise)

Discount movements were negative as the discounts of **Taiwan Fund Inc** (-36 bps) and **Fidelity China Special Situations** (-17 bps) widened by 4.7 and 2.3 percentage points, respectively.

Conversely, **VinaCapital Vietnam Opportunity Fund** (+12 bps) contributed outperformance as its discount narrowed by 3.6 percentage points.
